

King Trust Charitable Gift Fund (KTCGF) is a public charity offering a donor advised fund, created to encourage and assist donors in giving to charitable organizations.



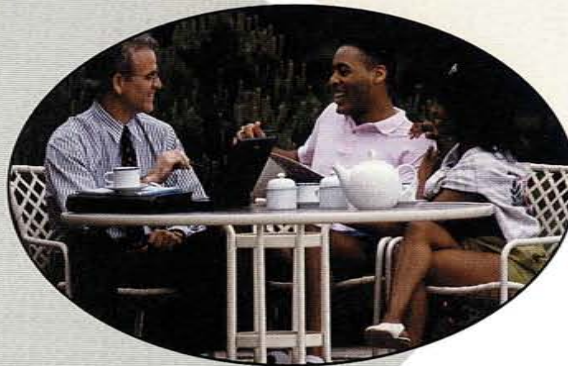
Like you, many people want to support a number of different charitable organizations. However, giving is many times complicated by the number of diverse issues you must face:

- ◆ Are the charities you support equipped to process the type of appreciated asset you want to donate?
- ◆ How can you split your gift of one appreciated asset to several charities?
- ◆ Can you receive a tax deduction now while determining the disposition of your gift later?

King Trust Charitable Gift Fund can *simplify* these issues, and more, for you.

King Trust Charitable Gift Fund is able to manage your funds and distribute them to a variety of charitable organizations, while helping you to avoid the high fees and time-consuming paperwork required to set up a family foundation. KTCGF is also able to manage the potential difficulties of dividing one gift of securities or real estate among multiple charities.

With KTCGF, you may make charitable contributions to your account when the time is right for you. Later, you or your appointed successor, if any, may recommend designations to various charities (anonymously if desired) when it would be most beneficial for them, even extending beyond your lifetime. Earnings begin to accumulate in your account from the date of your initial gift and are available for distribution.



King Trust Charitable Gift Fund is able to handle cash and most types of appreciated assets and distribute them to a wide variety of charitable organizations - religious, educational, medical, emergency relief, and many others. KTCGF is not limited geographically.

King Trust Charitable Gift Fund is an independent, not-for-profit organization, with its own board of directors. Income is derived from a modest fee for its services. A minimum gift is required to open an account.

How Does it Work?

Donor establishes an account with King Trust Charitable Gift Fund (gifts of cash, appreciated property, or a mix are accepted). For example:

The John and Mary Davis Family Foundation

(a sub-account of KTCGF)

Donor receives an immediate charitable income tax deduction for each gift and bypasses any capital gain to save on taxes.



Professional Asset Management

Gifts are professionally managed until ready for distribution.



Distributions to Approved Charitable Organizations

KTCGF makes distributions to the ultimate charitable beneficiary(ies) upon receiving the donor's recommendations.

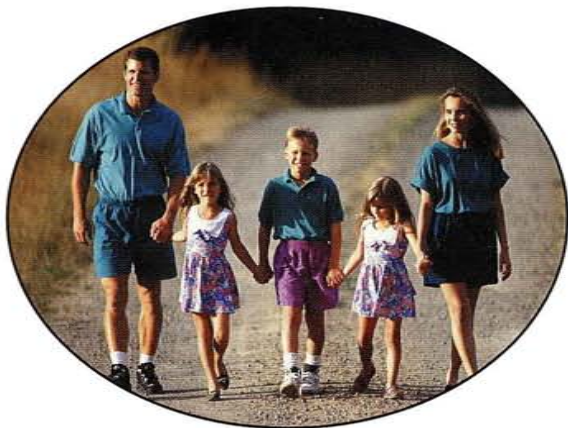
